Summit County, a body corporate and politic, grantee,

of Coalville, County of Summit, State of Utah, for the sum of TEN DOLLARS the following
described tract of land in Summit County, State of Utah, to-wit:

A strip, piece, or parcel of land 100 feet in width situate in the West half of Section 1, and in the Northeast quarter of Section 2, Township 2 South, Range 4 East of the Salt Lake Base and Meridian, being 50 feet in width, at right angles and/or radially, on each side of the centerline of the main spur track of the Union Pacific Railroad Company, as constructed, maintained and operated through, upon, over and across said Section 1 and 2, and extending from the Easterly line of the right of way of the Park City Branch of said Railroad Company to the North and South Center line of said Section 1.

The above described property being portions of the property conveyed to Union Pacific Railroad Company by Warranty Deed recorded July 18, 1924, as Entry No. 35371 in Book N of Warranty Deeds at Page 197 of the official records in the office of the Summit County Recorder, and by Quit Claim Deed recorded August 11, 1924, as Entry No. 35414 in Book E of Quit Claim Deeds at Page 375 of the official records in the office of the Summit County Recorder.

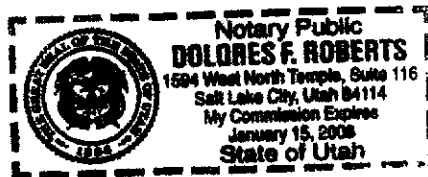
