# THIRD AMENDED DECLARATION OF CONDOMINIUM OF THE TOWNE PARK CONDOMINIUM PROJECT A UTAH CONDOMINIUM PROJECT

This Third Amended Declaration of Condominium is made and executed this 2 day of Avars 7, 2000, by the Towne Park Condominium Owner's Association, hereinafter referred to as the "Declarant."

### Recitals

- A. The "Declaration of Condominium of the Grant Square Condominium a Utah Condominium Project" was recorded beginning at Book 5513 Page 1059, as entry No. 3878705 (the "Original Declaration").
- B. The Original Declaration was amended by a document entitled "Amended Declaration of the Condominium of the Grant Square Condominium Project A Utah Condominium Project to Expand Condominium Project," which was recorded beginning at Book 5584 Page 485, as entry No. 3983809 (the "First Amended Declaration").
- C. The Original Declaration and First Amended Declaration were amended by a document entitled "Second Amended Declaration of Condominium of the Towne Park Condominium Project Formerly Known as the Grant Square Condominium Project a Utah Condominium project to Expand Condominium Project," which was recorded beginning at Book 6019 Page 765, as entry No. 4608991 (the "Second Amended Declaration").
- D. The Original Declaration, the First Amended Declaration, and The Second Amended Declaration shall be referred to herein collectively as the "Declarations."
- E. Management of the Towne Park Condominium Owners Association has been transferred by the original declarant in the Declaration to the Board of Directors (hereinafter referred to as Declarant) which is made up of persons elected by the Unit Owners pursuant to the Declarations.
- F. Declarant has obtained the approval of the Owners to amend the Declaration to more effectively and efficiently operate the Towne Park Condominium Project. Three amendments were agreed to by Owners holding more than two-thirds of the votes of the Association pursuant

to section 17.05 of the Declarations.

G. Declarant mailed to each Owner the proposed amendments and a ballot which are attached hereto as Exhibit A. Declarant received ballots from Owners holding at least two thirds of votes of the Association agreeing with the three amendments. The ballots are attached as Exhibit B, incorporated herein, and recorded herewith pursuant to the requirement of section 17.05 of the Declaration.

NOW, THEREFORE, pursuant to the foregoing, Declarant hereby makes and executes this Third Amended Declaration of Condominium for the benefit of the Project and for and on behalf of all of the Unit Owners.

- 1. <u>First Amendment</u>. Section 17.04 of the Declarations is amended by deleting the current section in its entirety, substituting the following:
  - 17.04 <u>Audit</u>. Any Owner may at any reasonable time, upon appointment and at his own expense, cause an audit or inspection to be made of the books and records maintained by the Association. The Association, at the expense of the Common Expense Fund, shall obtain an audit, on all books and records pertaining to the Project no less than once every three years, and copies thereof shall be furnished to the Owners.

- 5. Incorporation and Supplementation of Declaration. This document is supplemental to the Declaration, which by reference is made a part hereof, and all the terms, covenants, conditions, restrictions, and provisions thereof, unless specifically modified herein, are to apply to this document and are made a part hereof as though they were expressly rewritten, incorporated, and included herein.
