Jacob Family Partnership, Grantor, a Utah general partnership, hereby GRANTS AND CONVEYS to the UTAH DEPARTMENT OF TRANSPORTATION, Grantee, at 4501 South 2700 West, Salt Lake City, Utah 84114, for the sum of TEN (\$10.00) Dollars, and other good and valuable consideration, the following described easement in Utah County, State of Utah, to-wit:

A perpetual easement, upon part of an entire tract of property, situate in the NE1/4 NE1/4 of Section 2, T.6S., R.1W., S.L.B.&M., for the construction, operation and maintenance of a drainage structure and appurtenant parts thereof incident to the widening of existing SR-68 (Redwood Road), known as project number F-0068(109)27. This easement shall run with the real property and shall be binding upon the Grantor and the Grantor's successors, heirs and assigns.

Beginning at a point on the project westerly right of way line, which point is 1,470.63 feet N.00°12'22"E. along the section line and 807.35 feet West from the East Quarter Corner of said Section 2, which point is 60.00 feet perpendicularly distant westerly from the control line of said project, at Engineer Station 387+40.00; and running thence the following four (4) courses along said right of way: (1) S.26°18'21"W.
