AMENDMENT TO DECLARATION OF PARKING SPACE AND STORAGE ALLOCATION FOR ARLINGTON PLACE CONDOMINIUMS

This AMENDMENT to the DECLARATION OF PARKING SPACE AND STORAGE ALLOCATION for ARLINGTON PLACE CONDOMINIUMS is made and executed by the ARLINGTON PLACE HOMEOWNERS ASSOCIATION, INC. of 2120 East 3900 South, Suite 301, Salt Lake City, Utah 84124 (hereinafter referred to as the "Association").

RECITALS

- A. The DECLARATION OF PARKING SPACE AND STORAGE ALLOCATION for ARLINGTON PLACE CONDOMINIUMS was recorded in the office of the County Recorder of Salt Lake County, Utah on or about June 24, 1996 as Entry No. 6390623 in Book 7429 at Page 188 of the official records (the "Declaration");
- B. As per the Declaration and Article XV of the Amended Declaration of Condominium for ARLINGTON PLACE CONDOMINIUMS the affirmative vote of at least 67% of the Percentage Interest is sufficient to reassign or reallocate the use of the parking spaces and storage units at ARLINGTON PLACE.
- C. The Association, acting for the benefit and at the behest of the Unit Owners at ARLINGTON PLACE, desires to reassign and reallocate the use of Parking Spaces P-26 and P-30.
 - D. All of the voting requirements have been satisfied.

NOW, THEREFORE, for the reasons recited above and for the benefit of the Project and the Unit Owners thereof, the Association hereby executes this AMENDMENT to the DECLARATION OF PARKING SPACE AND STORAGE ALLOCATION for the ARLINGTON PLACE CONDOMINIUMS for and on behalf of all of the Unit Owners, and the Declaration is hereby amended as follows:

1. Parking Space P-30 in UPPER PARKING LEVEL 2 is withdrawn as the assigned parking space for Unit No. 313 and is reassigned and reallocated and reserved for the common use and enjoyment of all of the Unit Owners and residents for purposes of providing access, space for

the garage/gate opener and room for a bike rack, or such other common use as the Management Committee may deem reasonable.

- 2. Parking Space P-26 in LOWER PARKING LEVEL 1, which was assigned to the manager, is hereby reassigned and reallocated and reserved for the exclusive use of Unit No. 313 to the exclusion of the other Units.
- 3. Parking Space P-32 in LOWER PARKING LEVEL 1 is hereby reassigned and reallocated and reserved for the exclusive use of Unit No. 804.
- 4. Parking Space P-20 in UPPER PARKING LEVEL 2 is hereby reassigned and reallocated and reserved for the exclusive use of Unit No. 405.
- 5. The Maps for LOWER PARKING LEVEL 1 and UPPER PARKING LEVEL 2 attached to the Declaration are deleted in their entirety and the LOWER PARKING LEVEL 1 AND UPPER PARKING LEVEL 2 Maps attached hereto as Exhibit "A" and incorporated herein by this reference are substituted in lieu thereof. The changes are highlighted on the original document.
- 6. In the event of any conflict, inconsistency or incongruity between the provisions of this amendment and any of the provisions of the Declaration, the provisions of this amendment shall in all instances govern and control.
- 7. The effective date of this Amendment is the date it is recorded in the office of the County Recorder of Salt Lake County, Utah.




