THIS FIRST AMENDMENT TO DECLARATION OF ELK RUN VILLAGES HOMEOWNERS ASSOCIATION (this "Amendment") is made and executed this 29 day of November, 2000, by ELK RUN, L.C., a Utah limited liability company, for itself, its successors, grantees and assigns ("Developer").

RECITALS:

- A. This Amendment modifies that certain document titled Declaration of Elk Run Villages Homeowners Association, Covenants Conditions and Restrictions of Lamplight Village, Moonlit Meadows, Aspen Village & Oak Meadows Estates at Elk Run P.U.D., a Planned Unit Development, Magna, Utah, made and executed by Developer on February 22, 2000 (the "Declaration"), which was recorded on March 22, 2000, as Entry No. 7600559 in Book 8349 at Page 8317 in the office of the Recorder, Salt Lake County, Utah. Capitalized terms that are not defined in this Amendment shall have the same meaning as set forth in the Declaration.
 - B. Developer desires to amend the Declaration as set forth below.

NOW, THEREFORE, Developer hereby declares as follows.

- 1. The name "ELK RUN VILLAGES P.U.D., PROPERTY OWNERS ASSOCIATION" set forth in Paragraph C of the Recitals of the Declaration is hereby deleted and shall be replaced with "ELK RUN ESTATES HOMEOWNERS ASSOCIATION, INC."
- 2. Section 1.8 of the Declaration is hereby deleted in its entirety and shall be replaced with the following:
 - "1.8 Association shall mean ELK RUN ESTATES HOMEOWNERS ASSOCIATION, INC., a Utah nonprofit corporation."
- 3. Section 10.4 of the Declaration is hereby deleted in its entirety and shall be replaced with the following:
 - "10.4 Consent in Lieu of Vote. In any case in which this Declaration requires for authorization or approval of a transaction, the assent or affirmative vote of a stated percentage of the votes present or represented at a meeting, such requirement may

be fully satisfied by obtaining, with or without a meeting, consents in writing to such transaction from all Members entitled to vote with respect to such transaction."

4. <u>Effect of Amendment</u>. Except as modified by this Amendment, the Declaration is ratified and affirmed.

Reserving unto Developer its employees, agents, and successors, however, such easements and rights of ingress and egress over, across, through, and under the above-descried tract and any improvements now or hereafter constructed thereon as may be reasonably necessary for the Developer, its employees, agents and successors (in a manner not inconsistent with the provisions of this Declaration) to engage in construction upon or to improve the roadways with
