Right of way for highway known as F.A. Project No. 219-A across the grantors land in the $E\frac{1}{2} SE\frac{1}{4}$ of Section 8, T. 4 N., R. 1 W., S. L. M. Said right of way is contained within a parcel of land 50 ft. wide, 50 ft. on the east side of the center line of survey of said project from Engineer's Station 78+02 to Engineer's Station 88+24; thence 60 ft. wide to Engineer's Station 99+06. Right of way for highway known as F. A. Project No. 220-A across the grantors land in the $N\frac{1}{2} NE\frac{1}{4}$ of Section 10, the $NW\frac{1}{4} NW\frac{1}{4}$ of Section 11, and the $SW\frac{1}{4} SW\frac{1}{4}$ of Section 2, T. 4 N., R. 1 W., S. L. M. Said right of way is contained within a parcel of land 150 ft. wide, 75 ft. on each side of the center line of survey of said project. Said center line is described as follows:
