NOTICE OF REVOCABLE PERMIT

NOTICE IS HEREBY GIVEN of that certain Revocable Permit (the "Permit") made and entered into as of 04/14/1998, between Salt Lake City Corporation, a municipal corporation of the State of Utah (the "City"), and PHILLIPS, JENNY G, Salt Lake City, Utah (the "Permittee"). The Permit affects the residence located at 2125 S YUMA ST, Salt Lake City, Utah, parcel number 16-22-105-002.

COMMENCING 536.25 FEET WEST & 235.55 FEET SOUTH FROM SOUTH FROM SOUTHEAST CORNER BLOCK 7 5 AC PLAT C BIG FIELD SUR SOUTH 80 FEET EAST 156.75 FEET NORTH 80 FEET WEST 156.75 FEET TO BEGINNING BEING IN NORTHWEST 1/4 OF NORTHWEST 1/4 SEC 22 T ISR 1E SL MER.

Pursuant to the terms of the Permit, the City has granted a license to the Permittee to encroach on the City's property to construct and maintain a street light, and appurtenant facilities (collectively the "Street Light"). Among other things, the Permit provides that the Permittee shall be responsible for maintaining the Street Light in accordance with specified standards; the Permittee shall pay all costs of electricity; the Permittee shall insure the Street Light; and the City shall not be responsible for personal injury or property damage caused by or relating to the Street Light. The Permit shall run with the land and bind future owners of the Permittee's property. The term of the Permit is perpetual, subject to revocation by the City upon thirty (30) day's written notice to the Permittee.


