THIS INDENTURE, Made this 25th day of January, 1921, by and between Mutual Coal Company, a Utah corporation, party of the first part, and L. F. RAINS, of Salt Lake City, Utah, party of the second part, WITNESSETH:

WHEREAS, said party of the first part is the owner of land in the southwest quarter of northwest quarter and northwest quarter of southwest quarter of Section 7, and the northeast quarter of southeast quarter of Section 12, Township 13
South, Range 8 East, Salt Lake Meridian, over which land the party of the second
part desires to construct, maintain and operate a surface tram-line for the purpose
of conveying coal from the coal mine or mines to be operated by the party of the second part, and for the purpose of transporting materials over said tram-line in the
operation of said coal property; and,

WHEREAS, the party of the first part is willing to convey to the party of the second part a right of way over its land for the purposes above mentioned:

NOW THEREFORE, in consideration of the sum of One Dollar and other valuable consideration in hand paid by the party of the second part to the party of the first part, receipt of which is hereby acknowledged, the party of the first part by these presents hereby grants to the party of the second part, his successors and assigns, a right of way twenty-five feet in width, the center line of said right of way being described as follows, towit:

Beginning at a point S. 14 deg. 14 min. E., 1783.9 feet from the northwest corner of Section 7, Township 13 South, Range 9 East. Salt Bake Base and Meridian:

Thence S. 29 deg. 53. min. E. 117 feet: Thence on a 38 degree curve to the right 60.6 feet: Thence S. 6 deg. 52 min. E. 114.5 feet; Thence on a 38 degree curve to the right 74.7 feet: Thence S 21 deg. 30 min. W. 104.2 feet: Thence on a 38 degree curve to the left 42.1 feet: Thence S. 5 deg. 28 min. W. 94.0 feet; Thence on a 38 degree curve to the left 36.2 feet; Thence S. 8 Deg. 18 min. E. 50 feet; Thence on a 38 degree curve to the right 203.5 feet; Thence S. 69 deg. 02 min. W. 532.0 feet; Thence on a 28 degree curve to the left 45.6 feet: Thence S. 56 deg. 16 min. W. 738 feet; Thence on a 28 degree curve to the right 58.9 feet; Thence S. 72 deg. 46 min. W. 190 feet: Thence on a 28 degree curve to the left 56.3 feet; Thence S. 57 deg. 0 min. W. 71 feet; Thence on a 28 degree durve to the right 31.6 feet; Thence S. 65 deg. 52 min. W. 175 feet, which point intersects the west boundary of the Northeast quarter of the South east Quarter of Section 12, Township 13 South, Range 8 East, Salt Lake Base and Meridian.

It is further agreed by the parties hereto that said right of way or easement shall be used only for the purpose of the construction, maintenance and operation of said surface tram-line, which shall be constructed and operated with as little interference as may be with other appliances or improvements now constructed, or which said first party may hereafter deem necessary to construct and operate in the operation of its coal mine, and that said second party shall pay all expenses incident to the overcoming of any obstacle caused by the constructing, maintaining and operating of said tram-line that may thereby occur or accrue to first party in the operation of its coal mines. If at any timethe party of the second part, its successors or assigns, shall discontinue to use said/right of way for the purposes aforesaid, then the land upon which said tram-line is constructed on the course above described shall revert

exclusive control thereof.
