WARRANTY DEED.

FLOYD EDWARDS and MARVA T. EDWARDS, his wife, grantors, of Charleston, Wasatch County, State of Utah, hereby convey and warrant to DOUGLAS C. EDWARDS, grantee, of the same place, for the sum of Ten Dollars (\$10.00) and other good and valuable considerations, the receipt of which is hereby acknowledged, the following described tracts of land, situated in Wasatch County, State of Utah, to-wit:

Beginning at the Southwest corner of Section 2, in Township 4 South of Range 4 East of the Salt Lake Meridian; and running thence South 22 chains; thence South 89°12' East 9 chains; thence North 6° West 6.53 chains; thence North 17°20' West 4 chains; thence North 85°40' East 7 chains; thence North 2°45' East 3.30 chains; thence North 58°50' West 2.85 chains; thence North 14°55' West 3.50 chains; thence North 27°30' East 2.91 chains; thence North 10° East 7.93 chains; thence North 6°40' West 2.62 chains; thence North 78°45' West 9.20 chains; thence West 4.75 chains, more or less, to the West line of said Section 2; thence South 11.17 chains, more or less, to the place of beginning.

ALSO THE TRACT: Lots Two (2) and Three (3), Block Six (6), in the Charleston Survey of Building Lots, situate in the West Half of the Southwest quarter (W $\frac{1}{2}$ SW $\frac{1}{4}$) of Section 14, Township 4 South, Range 4 East, of the Salt Lake Meridian, excepting the following part thereof: Beginning at the Southwest corner of Lot 2, Block 6, and running thence North 3.50 rods; thence East 26 rods; thence South 3.50 rods to the Southeast corner of Lot 3, Block 6; thence West 26 rods to the place of beginning.
