### NOTICE OF REVOCABLE PERMIT

NOTICE IS HEREBY GIVEN of that certain Revocable Permit (the "Permit") made and entered into as of 11/08/2001 between Salt Lake City Corporation, a municipal corporation of the State of Utah (the "City"), and ALBERT A BARBER AND SHARLEEN H BARBER, Salt Lake City, Utah (the "Permittee"). The Permit affects the Residence located at 2220 SOUTH PRESTON STREET, Salt Lake City, Utah, parcel number 16-21-276-016.

SOUTH 55 FEET OF THE NORTH 170 FEET OF LOT 5, BLOCK3, ROSSLYN HEIGHTS.

Pursuant to the terms of the Permit, the City has granted a license to the Permittee to encroach on the City's property to construct and maintain a street light, and appurtenant facilities (collectively the "Street Light"). Among other things, the Permit provides that the Permittee shall be responsible for maintaining the Street Light in accordance with specified standards; the Permittee *shall* pay all costs of electricity; the Permittee shall insure the Street Light; and the City shall not be responsible for personal injury or property damage caused by or relating to the Street Light. The Permit shall run with the land and bind future owners of the Permittee's property. The term of the Permit is perpetual, subject to revocation by the City upon thirty (30) day's written notice to the Permittee.


