## NOTICE OF REVOCABLE PERMIT

NORTH 45 FEET OF LOTS 1 TO 5, BLOCK 5, IDLEWILD ADDITION TOGETHER WITH HALF VACATED ALLEY ABUTTING ON THE NORTH.
