MEMORANDUM OF UNDERSTANDING

This memorandum of understanding is entered into as of the 10th day of March 2001, by and between Hardware Park Mountain Estates, a Utah Non-profit Corporation. hereinafter referred to as the "Association" and Ellis Fulmer, an individual, hereinafter referred to as "Fulmer".

- A. The Association desires to honor a certain gentleman's agreement between Fulmer and Empire Enterprises, the original developer of Hardware Park Mountain Estates, and will do so provided that both parties agree to the following terms:
 - 1. The ownership of the water right remains with the Association. The Association is granting the rightful use of said water, not to exceed the use for one cabin.
 - 2. Fulmer agrees to pay the assessment of said Association (Currently \$50.00 per year) for the maintenance and repair of access roads within the Association, the maintenance of the springs, and to provide security and other needs as the Board of Directors of the Association from time to time will assess. Should Fulmer, his heirs, successors, or assigns, at any time fail to pay the yearly assessment, this right and agreement is hereby terminated.
 - 3. Payment of this assessment in no way is to be construed as ownership in the Association, nor does it carry any voting rights.
- B. This memorandum of understanding shall be binding upon the parties hereto and their respective heirs, successors, and or assigns.
