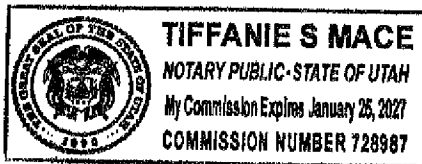


EXHIBIT A**(Legal Description of Property)**
