TRANSMISSION LINE EASEMENT

2. Wilford S. Gillispie and Olive J. Gillispie, his wife, Grantors, of Utah County, Utah, do hereby convey and warrant to UTAH POWER & LIGHT COMPANY, a corporation, its successors in interest and assigns, Grantee, for the sum of One (\$1.00) Dollar and other valuable consideration, a perpetual easement and right of way for the erection and continued maintenance, repair, alteration, inspection, relocation and replacement of the electric transmission, distribution, telephone and telegraph circuits of the Grantee, and two two pole towers and one guy anchor with the necessary guys, stubs, cross arms, braces and other attachments affixed thereto, for the support of said circuits, on, under, over, through, and across a tract of land fifty (50) feet in width, located in Utah County, Utah, and being twenty-five (25) feet on each side of the following described center line:

Beginning on north boundary line of grantor's land at a point 1320 feet south and 1335 feet east, more or less, from the west quarter corner of Section 7, T.6 S., R.3 E., S.L.B. & M., thence running S.31°24' E. 270 feet, more or less, to fence on south boundary line of said land; also beginning at fence on north boundary line of grantor's land at a point 110 feet north and 600 feet west, more or less, from the south quarter corner of said Section 7, thence running S.31°24' E. 1044 feet to existing two pole tower on said land; and being in the SE 1/4 of the SW 1/4 of said Section 7 and the NE 1/4 of the NW 1/4 of Section 18, Township and Range aforesaid.

Together with all rights of ingress and egress necessary or convenient for the full and complete use, occupation and enjoyment of the easement hereby granted, and all rights and privileges incident thereto, including the right to cut and remove timber, trees, brush, overhanging branches and other obstructions which may injure or interfere with the Grantee's use, occupation or enjoyment of this easement.

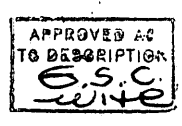
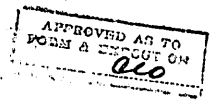
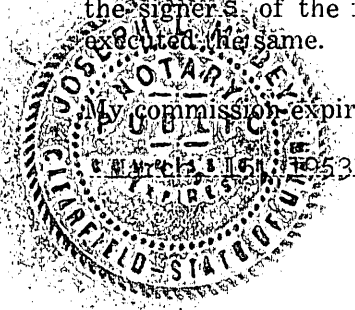
