THIS QUITCLAIM DEED made this 20th day of COUNTY RAILWAY COMPANY, a corporation of the State of Utah, whose address is 135 Jamison Lane, P.O. Box 68, Monroeville, Pennsylvania 15146, hereinafter referred to as "Grantor";

WITNESSETH: That in consideration of payment by Kaiser Coal Corporation, a corporation of the State Delaware, 102 South Tejon, Suite 800, Colorado Colorado 60903, hereinafter referred to as "Grantee", of Fifty Thousand Dollars (\$50,000), in hand paid, the receipt whereof is hereby acknowledged, and Grantee's further agreement to pay Grantor additional consideration in the amount of Two Hundred and Fifty Thousand Dollars (\$250,000) pursuant to that certain Option to Purchase Property and Real Estate dated December 11, 1984, between Grantor and Kaiser Steel Corporation (hereinafter the "Option Agreement"), THE CARBON COUNTY RAILWAY COMPANY does hereby grant, convey, assign and quitclaim to Grantee, without warranty of title (except as provided in Section 5 of the Option Agreement), all right, title and interest of the Grantor, in and to all those lands, including cuts and fills thereon, slopes, slope rights, draining ditches, culverts and other drainage facilities, buildings and hereditaments thereon, situated in Carbon County and Emery County in the State of Utah, which lands are more particularly described as set forth

on Exhibit "A" attached hereto, and including those certain rights-of-way granted pursuant to the provisions of the Act of March 3, 1875 (18 Stat. 482) as set forth in Exhibits "B" and "C" attached hereto, and subject to the exceptions set forth in Exhibit "D" attached hereto.

TOGETHER with all buildings and improvements thereupon erected, made or being, and all and every of the rights, alleys, ways, waters, privileges, appurtenances and advantages to the same belonging, or in anywise appertaining, and all of Grantor's interest in any and all agreements of any nature which affect the Property herein conveyed, including any and all parcels of land abutting or contiguous to the aforesaid right-of-way, in and to which the Grantor has any right, title or interest.

TO HAVE AND TO HOLD the premises aforesaid, with the privileges and appurtenances thereunto belonging, to Grantee, Grantee's successors and assigns forever.

Except as provided in and to the extent provided for in Section 5 of the Option Agreement, this conveyance is made subject to:

- (d) Public streets and roadways dedicated and in place as of the date first above written;
- (e) Any and all contracts, agreements or commitments which affect the Property herein conveyed and which run with title to lands, including but not limited to:
