

EXTENSION OF OIL AND GAS LEASE

WHEREAS, an Oil and Gas Lease dated the 10th day of March, 1977, was executed by FIRST SECURITY BANK OF UTAH, NATIONAL ASSOCIATION, as Trustee Bank under Trust Agreement and Conveyance in Trust dated May 29, 1962, between VAL A. BROWNING et al, FIRST SECURITY BANK of UTAH, NATIONAL ASSOCIATION, and MATT S. BROWNING, as Lessor to FILON EXPLORATION CORPORATION, as Lessee, covering the following described land in Box Elder County, Utah, to-wit:

TOWNSHIP 8 NORTH, RANGE 7 WEST, SLM

containing 2,114.56 acres, more or less, which lease is recorded in Book 291 at page 456 of the records of said County.

AND WHEREAS, said Lease, insofar as it covers all the land described therein is now held and owned by Bow Valley Exploration (U.S.) Inc., Crux, Ltd, Mapco Production Company, Louisiana Land & Exploration Company, North Central Oil Corporation, Dome Oils, Inc., Kenneth D. Luff, and Robert L. Nance;

AND WHEREAS, said lease expires in the absence of drilling operations, on the 10th day of March, 1982 and the hereinabove named owners of said lease desire to have the term of said lease extended:

NOW THEREFORE, the undersigned, for and in consideration of TEN DOLLARS (\$10.00) in hand paid, the receipt and sufficiency of which is hereby acknowledged does hereby agree that the term of said lease shall be and is hereby extended, with the same tenor and effect as if such extended term had been originally expressed in such lease, for a term of five (5) years from the date of the said expiration thereof and as long thereafter as oil and gas (including casinghead gas) is produced from any well on the land covered by said lease, subject however in all other respect to the provisions and conditions of said lease.

This Extension of Oil and Gas Lease is executed by the undersigned with the understanding and upon the condition that the above named owners and holders of said Oil and Gas Lease will, within six (6) months from the date hereof commence gravity or seismic exploration operations within the area in which the lands covered by said Oil and Gas Lease are located to-wit: Townships 7, 8, 9 and 10 North, Ranges 6, 7 and 8 West SLM, in Box Elder County, Utah, such operations to be conducted in conformity with

the rules and regulations of the government agency or agencies having jurisdiction thereof, and will continue such operations for such period of time as may be deemed necessary by such owners and holders of said lease.

As an additional consideration to the undersigned for the execution of this Extension of Oil and Gas Lease, the same is executed with the understanding and upon the further condition that as to any well or wells commenced upon any of the lands covered by the lease after the expiration of the original five (5) year term specified in the lease and thereafter completed as a producing well, the Lessor's royalty interest in the production from any such well or wells shall be three twentieths (3/20) in lieu and instead of the one-eighth (1/8) specified in paragraphs numbered 1, 2 and 3 of the lease, subject, however, to the provisions of paragraph numbered 6 of the lease.

All of the terms and provisions of this extension agreement shall extend to and be binding upon all parties to said Oil and Gas Lease, and their heirs, administrators, executors, successors and assigns.
