Whereas, the related Plat Map(s) for Phase X of the Project has also been recorded in the office of the County Recorder of Salt Lake County, Utah.

Whereas, the Ninth Supplement to the Declaration of Condominium for VIVANTE was

Whereas, the Tenth Supplement to the Declaration of Condominium for VIVANTE was recorded in the office of the County Recorder of Salt Lake County, Utah on the 18th day of Inventor, 2002 as Entry No. 8424366 in Book 8685 at Page 8449 of the official records (the "Tenth Supplement").

Whereas, the related Plat Map(s) for Phase XI of the Project has also been recorded in the office of the County Recorder of Salt Lake County, Utah.

Whereas, the Eleventh Supplement to the Declaration of Condominium for VIVANTE was recorded in the office of the County Recorder of Salt Lake County, Utah on the 18th day of as Entry No. 8424368 in Book 8685 at Page 8459 of the Official Records of the County Recorder of Salt Lake County, Utah (the "Eleventh Supplement").

Whereas, the related Plat Map(s) for Phase XII of the Project has also been recorded in the office of the County Recorder of Salt Lake County, Utah.

Whereas, under Article III, Section 45 of the Declaration, Declarant reserved an option, until the seven (7) years from the date following the first conveyance of a Unit in Phase I to a Unit purchaser, to expand the Project in accordance with the Act.

Whereas, Declarant is the fee simple owner of record of that certain real property located in Salt Lake County, Utah and described with particularity on Exhibit "A-13" attached hereto and incorporated herein by this reference (the "Phase XIII Property").

Whereas, under the provisions of the Declaration, Declarant expressly reserved the absolute right, subject to the approval of the Department of Veterans Affairs, to add to the Project any or all portions of the Additional Land at any time and in any order, without limitation.

Whereas, Declarant desires to expand the Project by creating on the Phase XIII Property a residential condominium development.

Whereas, Declarant now intends that the Phase XIII Property shall become subject to the Declaration.

NOW, THEREFORE, for the reasons recited above, and for the benefit of the Project and the Unit Owners thereof, Declarant hereby executes this TWELFTH SUPPLEMENT TO THE DECLARATION OF CONDOMINIUM FOR VIVANTE.

- 1. <u>Supplement to Definitions</u>. Article I of the Declaration, entitled "Definitions," is hereby modified to include the following supplemental definitions:
- A. <u>Twelfth Supplement to the Declaration</u> shall mean and refer to this TWELFTH SUPPLEMENT TO THE DECLARATION OF CONDOMINIUM FOR VIVANTE.
- B. Twelfth Supplemental Map or Phase XII Map shall mean and refer to the Twelfth Supplemental Plat Map for Phase XII of the Project, prepared and certified to by Gary Wier, a duly registered Utah Land Surveyor holding Certificate No. 333098, and filed for record in the Office of the County Recorder of Salt Lake County, Utah concurrently with the filing of this Twelfth Supplement to the Declaration.

Except as otherwise herein provided, the definition of terms contained in the Declaration are incorporated herein by this reference.

- 2. <u>Legal Description</u>. The real property described in Exhibit A-13 is hereby submitted to the provisions of the Act and said land shall be held, transferred, sold, conveyed and occupied subject to the provisions of the Declaration, as supplemented.
- 3. <u>Annexation</u>. Declarant hereby declares that the Phase XIII Property shall be annexed to and become subject to the Declaration, which upon recordation of this Eleventh Supplement to the Declaration shall constitute and effectuate the expansion of the Project, making the real property described in Exhibit A-13 subject to the functions, powers, rights, duties and jurisdiction of the Association.
- 4. <u>Total Number of Units Revised</u>. As shown on the Phase XIII Map, a Building and twelve (12) additional Units are or will be constructed and/or created in the Project on the Phase XIII Property. The additional Building and Units are located within a portion of the Additional Land. Upon the recordation of the Phase XIII Map and this Twelfth Supplement to the Declaration, the total number of Units in the Project will be one hundred and two (102). The additional Building and Units are substantially similar in construction, design and quality to the Buildings and Units in the prior Phases.
- 5. <u>Percentage Interest Revised</u>. Pursuant to the Act and the Declaration, Declarant is required, with the additional Units, to reallocate the undivided percentages of ownership interest in the Common Areas and Facilities. Eleventh Revised Exhibit "C" (Percentages of Undivided Ownership Interests) to the Declaration is hereby deleted in its entirety and "Twelfth Revised Exhibit 'C," attached hereto and incorporated herein by this reference, is substituted in lieu thereof.
