

## SCHEDULE 'A' - LEGAL DESCRIPTION

### Patent Parcel:

The Southwest Quarter of the Northeast Quarter; the Southeast Quarter of the Northwest Quarter; the Northeast Quarter of the Northeast Quarter of the Northeast Quarter of the Southwest Quarter; the South half of the Northeast Quarter of the Northeast Quarter of the Southwest Quarter; the Northeast Quarter of the Southwest Quarter of the Northeast Quarter of the Southwest Quarter; the South half of the Southwest Quarter of the Northeast Quarter of the Southwest Quarter; the Southeast Quarter of the Northeast Quarter of the Southwest Quarter; the Southeast Quarter of the Southwest Quarter of Section 12, Township 12 North, Range 7 East of the Salt Lake Base and Meridian.

Less and Excepting therefrom all oil, gas, sodium and potash, etc., and a 25 foot right-of-way for public use along the South line of the Southeast Quarter of the Southwest Quarter, from the County road West, to the West line of the Southeast Quarter of the Southwest Quarter, all as previously reserved in that certain Patent recorded in Book O4, Page 387 in the office of the Recorder of Rich County, Utah.

Subject to a right-of-way for the existing County Road for public access and use in the Southeast Quarter of the Southwest, and also subject to a right-of-way for an existing power transmission line.

### TRACT 1:

Part of the Southeast Quarter of the Northeast Quarter of Section 12, Township 12 North, Range 7 East of the Salt Lake Base and Meridian lying Westerly of the County road right-of-way. Said West line of County Road right-of-way, being described as follows: Beginning at Station 415+16.07, a point on the Northerly property line of Peart land in Section 12, Township 12 North, Range 7 East, whence the Northeast Corner thereof bears North 17°51'36" East 1,426.66 feet; thence South 16°52'03" West 76.35 feet to Station 415+92.42; thence South 20°30'25" West 587.75 feet to Station 421+80.17; thence South 27°01'03" West 764.93 feet to Station 429+45.10; thence South 34°43'30" West, 63.59 feet to Station 430+08.69, a point on the Southerly property line of Peart land in Section 12, Township 12 North, Range 7 East, whence the Northeast Corner thereof bears North 21°07'46" East, 2,910.90 feet.

### TRACT 2:

The Northeast Quarter of the Northwest Quarter and the North half of the Northeast Quarter of Section 13; and the Southeast Quarter of the Southeast Quarter of Section 12, all in Township 12 North, Range 7 East of the Salt Lake Base and Meridian.

Lot 1, (Lot 1 being the Northwest Quarter of the Northwest Quarter) and Lot 2, (Lot 2 being the Southwest Quarter of the Northwest Quarter) in Section 7, Township 12 North, Range 8 East of the Salt Lake Base and Meridian.

Also, the North half of the Southeast Quarter and the Southwest Quarter of the Southeast Quarter of Section 12, Township 12 North, Range 7 East of the Salt Lake Base and Meridian.

**TRACT 3:**

The Southeast Quarter of Section 12, Township 12 North, Range 7 East of the Salt Lake Base and Meridian. LESS AND EXCEPTING THEREFROM: Commencing at a point 685 feet West from the Northeast Corner of the Southeast Quarter of Section 12, Township 12 North, Range 7 East of the Salt Lake Base and Meridian, and running thence South 220 feet; thence West 198 feet; thence North 220 feet; thence East 198 feet to the point of beginning.
