**SECOND SUPPLEMENT TO THE  
DECLARATION OF CONDOMINIUM FOR INTRIGUE AT JORDAN LANDING,  
(A Utah Expandable Condominium Project)**

This SECOND SUPPLEMENT TO THE DECLARATION OF CONDOMINIUM FOR INTRIGUE AT JORDAN LANDING, an expandable Utah condominium project, is made and executed by INTRIGUE, L.C., 8522 South 1300 East, Suite D 201, Sandy, Utah 84094 (the "Declarant").

**RECITALS**

Whereas, the original Declaration of Condominium for Intrigue at Jordan Landing was recorded in the office of the County Recorder of Salt Lake County, Utah on the 22 day of June, 2001 as Entry No. 7929784 in Book 8471 at Page(s) 3585-3654 of the Official Records of the County Recorder of Salt Lake County, Utah (the "Declaration").

Whereas, the related Plat Map(s) for Phases I and II of the Project have also been recorded in the office of the County Recorder of Salt Lake County, Utah.

Whereas, the First Supplement to the Declaration of Condominium for Intrigue at Jordan Landing was recorded in the office of the County Recorder of Salt Lake County, Utah on the 22 day of JUNE, 2001 as Entry No. 7929784 in Book 8471 at Page 3585 of the Official Records of the County Recorder of Salt Lake County, Utah (the "First Supplement").

Whereas, the related Plat Map(s) for Phase III of the Project has also been recorded in the office of the County Recorder of Salt Lake County, Utah.

Whereas, under Article III, Section 50 of the Declaration, Declarant reserved an option, until the seven (7) years from the date following the first conveyance of a Unit in Phase I to a Unit purchaser, to expand the Project in accordance with the Act.

Whereas, Declarant is the fee simple owner of record of that certain real property located in Salt Lake County, Utah and described with particularity on Exhibit "A-4" attached hereto and incorporated herein by this reference (the "Phase IV Property").

Whereas, under the provisions of the Declaration, Declarant expressly reserved the absolute right to add to the Project any or all portions of the Additional Land at any time and in any order, without limitation.

Whereas, Declarant desires to expand the Project by creating on the Phase IV Property a residential condominium development.

Whereas, Declarant now intends that the Phase IV Property shall become subject to the Declaration.

## A G R E E M E N T

NOW, THEREFORE, for the reasons recited above, and for the benefit of the Project and the Unit Owners thereof, Declarant hereby executes this SECOND SUPPLEMENT TO THE DECLARATION OF CONDOMINIUM FOR INTRIGUE AT JORDAN LANDING.

1. Supplement to Definitions. Article I of the Declaration, entitled "Definitions," is hereby modified to include the following supplemental definitions:

A. Second Supplement to the Declaration shall mean and refer to this Second Supplement to the Declaration of Condominium for Intrigue at Jordan Landing.

B. Second Supplemental Map or Phase IV Map shall mean and refer to the Supplemental Plat Map for Phase IV of the Project, prepared and certified to by J. Michael De Mass, a duly registered Utah Land Surveyor holding Certificate No. 174007, filed for record in the Office of the County Recorder of Salt Lake County, Utah concurrently with the filing of this First Supplement to the Declaration.

Except as otherwise herein provided, the definition of terms contained in the Declaration are incorporated herein by this reference.

2. Legal Description. The real property described in Exhibit A-4 is hereby submitted to the provisions of the Act and said land shall be held, transferred, sold, conveyed and occupied subject to the provisions of the Declaration, as supplemented.

3. Annexation. Declarant hereby declares that the Phase IV Property shall be annexed to and become subject to the Declaration, which upon recordation of this Second Supplement to the Declaration shall constitute and effectuate the expansion of the Project, making the real property described in Exhibit A-4 subject to the functions, powers, rights, duties and jurisdiction of the Association.

4. Total Number of Units Revised. As shown on the Phase IV Map, five (5) additional Buildings and thirty (30) additional Units are or will be constructed and/or created in the Project on the Phase IV Property. The additional Buildings and Units are located within a portion of the Additional Land. Upon the recordation of the Phase IV Map and this Second Supplement to the

Declaration, the total number of Units in the Project will be one hundred and seventeen (117). The additional Buildings and Units are substantially similar in construction, design and quality to the Buildings and Units in the prior Phases.

5. Percentage Interest Revised. Pursuant to the Act and the Declaration, Declarant is required, with the additional Units, to reallocate the undivided percentages of ownership interest in the Common Areas and Facilities. Exhibit "C" (Percentages of Undivided Ownership Interests) to the Declaration is hereby deleted in its entirety and "Revised Exhibit 'C,'" attached hereto and incorporated herein by this reference, is substituted in lieu thereof.

6. Effective Date. The effective date of this Second Supplement to the Declaration and the Phase IV Map shall be the date on which said instruments are filed for record in the Office of the County Recorder of Salt Lake County, Utah.

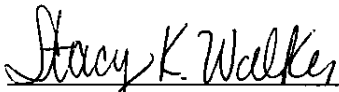
