CAMMAN LLC., a Utah Limited Liability Company, Grantor, GRANTS AND CONVEYS to PROVO CITY CORPORATION a MUNICIPAL CORPORATION, at 351 West Center, Provo, UT 84601, Grantee, for the sum of TEN DOLLARS (\$10.00) and other good and valuable consideration, a perpetual easement upon part of the Grantor's property in Utah County, State of Utah, for the purpose of constructing and maintaining a public utility easement to facilitate the construction of "Frontrunner South Commuter Rail". It is understood that the Grantor and Grantee shall not build or construct, nor permit to be built or constructed, any building or other permanent structures upon, over or across said easement. The easement shall run with the Real Property and shall be binding upon the Grantor and the Grantor's successors, heirs and assigns, and includes and conveys all rights of grantor to change the vertical distance or grade of said cut/fill slopes without express written permission from the grantee. The boundary of said part of the Grantor's property is described as follows:

A PORTION OF THE GRANTOR'S PROPERTY, DEFINED IN THAT CERTAIN WARRANTY DEED RECORDED AUGUST 31, 2006 AS ENTRY 122265, SITUATE IN THE NORTHEAST QUARTER OF SECTION 12, TOWNSHIP 7 SOUTH, RANGE 2 WEST, SALT LAKE BASE AND MERIDIAN, BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS:

COMMENCING NORTH 3004.42 FEET AND EAST 195.85 FEET FROM THE SOUTH QUARTER CORNER OF SAID SECTION 12, THENCE NORTH 89°00'00" WEST 6.00 FEET; THENCE SOUTH 00°13'27" EAST 9.15 FEET; THENCE SOUTH 88°46'55" EAST 5.80 FEET; THENCE NORTH 01°00'00" EAST 9.17 FEET TO THE POINT OF BEGINNING.
