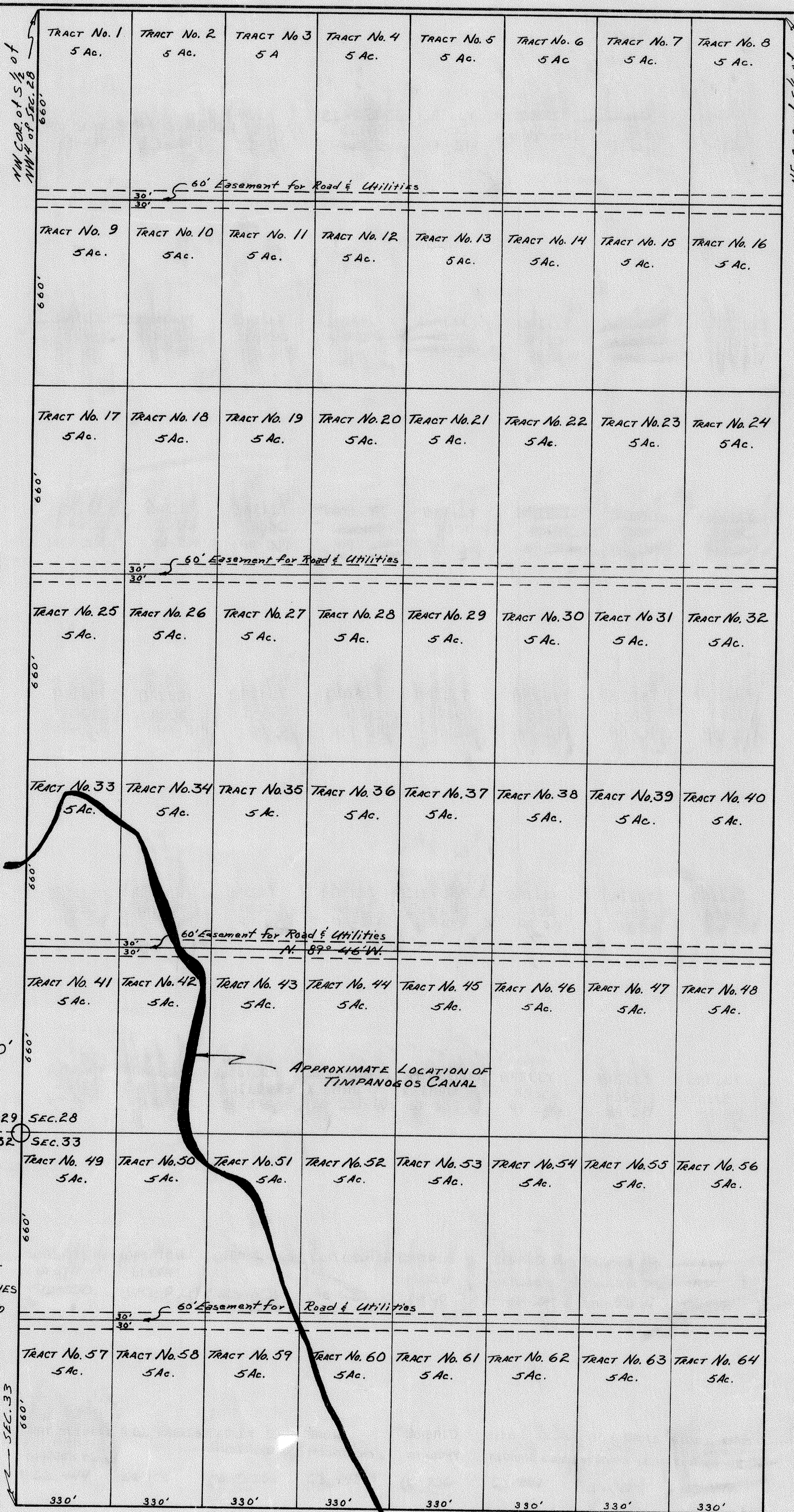


LEGAL DESCRIPTION OF LAND TRACTS
