: ADMINISTRATOR AND DECREE OF DISTRIBUTION

Walter H. Meadows, administrator of the estate of Arthur Mann Meadows, deceased, having heretofore filed in this court his petition setting forth, among other things, that said estate is in a condition to be closed, and having with said petition filed his final account as the administrator of said estate, praying that the same be settled, allowed, and approved and having also filed his petition for the distribution of said estate, from which said petition it is made to appear that a portion of said estate remains to be distributed to the heirs at law of said deceased and praying that such residue be distributed in accordance with the terms of a certain agreement made and entered into between the heirs of said deceased.

And the report and final account of said administrator together with his petition for the settlement and allowance of the same and his petition for the distribution of said estate coming on regularly to be heard on the 2nd day of November A. D. 1938, and it appearing to the satisfaction of the court that the Clerk of said court duly and regularly fixed the time and place for the hearing of said account and petition and that notice thereof was duly and regularly given to the heirs at law of said deceased for the time and in the manner required by law; that said final account of said administrator after due examination was found to be correct, and that said administrator is entitled to have the same settled, allowed, and approved; and it appearing to the court that the payments made by said administrator in the administration of said estate were properly and necessarily made; that all taxes upon the property of said estate have been fully paid and discharged and that all funeral expenses and all of the expenses of the last illness of said deceased and all of the charges, costs, and expenses of administration and all of the debts of said deceased have been fully paid and discharged and that the residue of said estate, consisting of the property hereinafter particularly described is now ready for distribution, and that said estate is now in a condition to be closed.

And it appearing to the court that said administrator has duly made and returned to this court a true and correct inventory and appraisement of all of the property of said estate which has come to his possession and knowledge; that said administrator has duly and regularly published a notice to creditors to present their claims against said deceased and that said notice was published in the Mining Review, a newspaper published in Salt Lake City, Utah in the manner and for the time provided by law; that more than two months have elapsed since the first publication thereof and that there has been duly filed and entered in said cause a decree that due and legal notice has been given to creditors for the time and in the manner provided by law.

That the property of said estate consists of approximately 50 acres of agricultural lands which it has been agreed shall be divided and partitioned by the heirs at law of said deceased, pursuant to the terms of a certain agreement on file in this cause; that the children and heirs at law of said deceased have each received their share of the proceeds from said agricultural lands during the course of administration in proportion to the amount of land received by the terms of said agreement; that said administrator has expended the sum of \$1102.99 in payment of the last illness and funeral and burial expenses and the costs and expenses of administration, the vouchers showing such expenditures together with a statement of such disbursements having been duly presented and filed and the payments approved by this court and the court finds that said payments made by said administrator have been expended as necessary costs of administration and in payment of the funeral and burial expenses and expenses of the last illness of said deceased and that the amounts paid by said administrator as aforesaid have been contributed by the children and heirs aforesaid in proportion to their interest in said estate, and that the said Walter H. Meadows has waived the payment of his statutory fees as the administrator of said estate, and the court finds that all of said statements and accounts of said administrator are true and correct, and said report and account of said administrator is hereby settled, allowed, and approved;

That said deceased died intestate in Cottonwood, Salt Lake County, State of Utah on the 14th day of May, 1935; that said deceased at the time of his death was unmarried; that the wife of said deceased, Margaret S. Meadows, died at Cottonwood, Salt Lake County, State of Utah on February 9, 1935; that said deceased left surviving him 10 children who were his sole and only heirs at law and whose names, ages, and relationship to said deceased are as follows:

The court finds that the above named children are entitled as the next of kin and heirs at law of said deceased to have distributed to them the entire residue of said estate; that since the date of the death of said deceased all of said children who reside in Cottonwood, Salt Lake County, State of Utah have jointly used and occupied the agricultural lands above referred to and have jointly received the rents, issues and profits arising from the operation of the same, and that said children and each of them on the 12th day of October, 1938 entered into a certain agreement in writing, the original of which has heretofore been filed in this cause and that under and pursuant to the terms thereof, said children and heirs have agreed that the property described in said agreement shall be conveyed to the respective children and heirs of said deceased as in said agreement set forth and as particularly set forth and described in the various exhibits attached to said agreement, which said exhibits are marked Exhibit A to Exhibit J, inclusive together with the water rights therein mentioned and described; and the court finds that under and pursuant to the terms of said agreement, each of the children are entitled to receive the real estate and water rights as the same are specifically described and referred to in said agreement and said exhibits.

NOW THEREFORE, on motion of A. H. Hougaard, attorney for said administrator and no objections being made thereto, and it satisfactorily appearing to the court that due notice of the hearing upon the report and account of said administrator and upon his petition for distribution has been duly and regularly given in the manner and for the time required by law, it is HEREBY ORDERED, ADJUDGED, AND DECREED that the residue of said estate hereinafter more particularly described and now remaining in the hands of said administrator be, and the same is, hereby distributed as follows, to-wit:
