THIS INDENTURE, Made this 31st day of December, A.D., 1924, between the Carbon Fuel Company, a Utah corporation, hereinafter called "first party," and the Mutual Coal Company, a Utah corporation, hereinafter called "second party", Witnesseth:

In consideration of the sum of One Dollar and other valuable consideration, the receipt whereof is hereby acknowledged, the first party does hereby grant unto the second party, its successors and assigns forever, an easement over that certain strip of land described as follows

A strip of land 25 feet on each side of a center line as follows: Beginning at a point which bears N. 0 deg. 32 min. E. 237.0 feet from the center of Section 7, Township 13 South, Range 9 Hast, S.L. B. and M.; thence into the SEL of NW of said Section 7 on a 10 deg. curve to the left a distance of 162.0 feet; thence south 58 deg. 44 min.
