Grantors do hereby grant, transfer and convey unto the Grantee a perpetual easement to use, operate, inspect, repair, maintain, replace or expand public utilities and drainage facilities, under and along any portion of the property described herein which may be owned by Grantors in Washington County, State of Utah.

The perpetual easement shall be as described in Exhibit "A", attached hereto and incorporated herein by this reference.
