The project has the option to record supplemental amendments, each such Unit consisting of a Unit and an appurtenant undivided, but equal, interest in and to the Common Areas and Facilities. Such Units comprise the minimum number of Units in the Project and give each Owner an undivided interest in the Common Areas and Facilities. If all of the Additional Land is added into the Project pursuant Sections 2.03 and 2.04, the maximum number of Units in the Project will be 135 and each Unit Owner will have a undivided interest in the Common Areas and Facilities.
 - a. Exhibit "B" to this amendment, in its entirety, is added to the Declaration.
- 2. Except as amended by the provisions of this Third Amendment to Declaration, the Declaration shall remain unchanged and shall constitute the entire Declaration of Condominium for the Project, reflecting the conversion of portions of the Convertible Land as described on the Third Supplemental record of Survey Map and the attached Exhibit "A".
- 3. This Third Amendment to Declaration shall be recorded in the Public Records simultaneously with the Project's Third Supplemental Record of Survey Map, consisting of three sheets prepared by Roger D. Dudley, a
