10. Each party is ordered to execute and deliver to the other party without cost

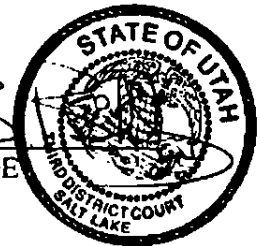
any documents necessary to implement the provisions of this Decree of Divorce.

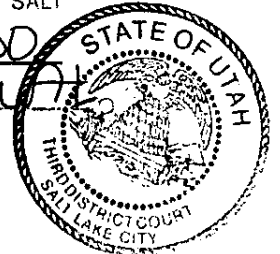
