The second paragraph of Section 23 of the Declaration of Condominium of the Park Condominium Project, entitled Payment of Expenses, is hereby amended to read:

Each time legal title to a Unit passes from one person to another, within thirty (30) days after the effective date of such title transaction the new Unit Owner shall pay to the Committee, in addition to any other required amounts the sum of \$5.00. The provisions of the following Section 24 shall apply to the collection of such sum. The sums received by the Committee pursuant to this Paragraph shall be used to reimburse the Association treasury for the expenses incurred in providing new Unit Owners with a copy of this Declaration and subsequent by-laws.
