## GRANT OF EASEMENT

Salt Lake County, a body corporate and politic of the State of Utah, Grantor, hereby GRANTS AND CONVEYS to the CITY OF SOUTH JORDAN, a municipal corporation of the State of Utah, Grantee, for no fee, the following described easement of land in Salt Lake County, State of Utah:

An easement upon part of an entire tract of property, situate in Section 15, T.3S., R1.W., SLB&M, for the installation and maintenance of electric utilities, and appurtenant parts thereof. The boundaries of said part of an entire tract are described as follows:

Beginning at a point in the westerly right of way line of Redwood Road, which is South 0°06'05" West 372.06 feet along the Quarter Section line and North 89°53'55" West 53.0 feet and South 0°06'05" West 67.18 feet along said westerly right of way line from the North Quarter corner of said Section 15; thence North 89°59'54" West 7.0 feet; thence South 0°06'05" West 16.0 feet; thence South 89°59'54" East 7.0 feet to said right of way line; thence North 0°06'05" East 16.0 feet along said right of way line to the point of beginning.

The above described part of an entire tract contains 112.0 square feet in area.

The Grantee shall have the right to construct, operate, maintain and remove the facility, together with appurtenant structures, from time to time as the Grantee may require. The Grantee shall have the right of ingress and egress over and across the immediate adjacent land of the Grantors to and from the above-described property. The Grantee shall have the right to clear and remove all trees and other obstructions within the Easement, which may interfere with the use of the Easement by the Grantee.


The Grantor reserves the right to occupy, use and cultivate said property for all purposes not inconsistent with the rights herein granted.

Together with and subject to any and all easements, rights-of-way and restrictions appearing of record or enforceable in law and equity.


