

Lot 350, DIMPLE DELL VILLAGE NO. 3, according to the official plat thereof, as recorded in the office of the County Recorder of said County.

Together with a right of way over and across the following described property:

Beginning at a point which is South 89° 37' 42" East along the Section Line 182.98 feet from the South Quarter Corner of Section 10, Township 3 South, Range 1 East, Salt Lake Base and Meridian, and running thence due North 164.805 feet to the P.C. of a 719.754 foot radius curve the center of which bears due West; thence Northwesterly along the arc of said curve to the left, a distance of 339.18 feet through a Central Angle of 27°; thence North 27° West 63.639 feet to the P.C. of a 770.378 foot radius curve the Center of which bears North 63° East; thence Northerly along the arc of said curve to the right a distance of 367.46 feet through a Central Angle of 27° 19' 45" thence North 0° 19' 45" East 425.305 feet; thence South 89° 54' 08" East 13.50 feet to a point which is South 0° 19' 45" West 1326.55 feet from the Center of said Section 10; thence South 89° 54' 08" East 56.50 feet; thence South 0° 19' 45" West 425.587 feet to the P.C. Of a 700.378 foot radius curve the Center of which bears South 89° 40' 15" East; thence Southeasterly along the arc of said curve to the left a distance of 334.07 feet (through a Central Angle of 27° 19' 45", thence South 27° East 63.639 feet) to the P.C. of a 789.754 foot radius curve the Center of which bears South 63° West; thence Southerly along the arc of said curve to the right a distance of 372.16 feet through a Central Angle of 27°; thence due South 165.259 feet to the South line of said Section 10; thence North 89° 37' 42" West along said Section line 70.00 feet to the point of beginning.
