

NOTICE OF INTENT TO CREATE SPECIAL IMPROVEMENT DISTRICT 7300 WEST, 13700 SOUTH, 13800 SOUTH

Creation of Improvement District: Pursuant to Utah Code Section 17A-3-205, Salt Lake County hereby gives notice of its intention to levy an assessment to pay for the costs to improve 7300 West, 13700 South, and 13800 South west of 6400 West and south of 13400 South in the Unincorporated area of Salt Lake County.

- A. Purpose: The purpose of this levy is to improve the roadways to minimum Salt Lake County rural standards, including pavement and drainage so that they may be included in Salt Lake County's year-round maintenance plan.
- B. Method of Assessment: The methods under which the assessment are proposed to be levied are a combination of the following:

70% of the assessment based on the number of lots within the whole project 30% of the assessment based on roadway frontage

C. District Description: The district includes all the lots adjacent or using the following roadways as their primary access:

7300 West 13400 South to Rose Canyon Road 13700 South 7300 West east to the Herriman City Boundary 13800 South 7300 West east to the Herriman City Boundary

- D. Proposed Improvements: The proposed improvements include upgrading the roadways to meet County rural standards including road base and asphalt to a width of 20 feet plus a reasonable shoulder. Any drainage facilities required will also be included.
- E. Estimated Cost: The overall cost of the project is estimated as follows:

7300 West \$240,000 13700 South \$120,000 13800 South \$120,000 Total \$480,000

- F. Proposed Assessments: It is proposed to levy assessments on property in the district to pay all or a portion of the cost of the improvements according to the estimated direct and indirect benefits to be derived from them by the property. These benefits need not actually increase the fair market value of the assessed property.
- G. Protests: Written protests shall be filed by Thursday March 6, 2003 by 4:30 p.m. to

A public hearing to consider these protests will be held by the Salt Lake County Council March 11, 2003 at 4:00 p.m. in the Council Chambers 2001 South State N 1000, Salt Lake City Utah.

H. Reserve Fund: The governing body does not intend to create and fund from assessments a separate reserve fund.

CREATING A SPECIAL IMPROVEMENT DISTRICT KNOWN AS 7300 WEST AREA SPECIAL IMPROVEMENT DISTRICT

A RESOLUTION OF THE COUNTY COUNCIL OF SALT LAKE COUNTY, UTAH, CREATING AND ESTABLISHING A SPECIAL IMPROVEMENT DISTRICT KNOWN AS THE "7300 WEST AREA SPECIAL IMPROVEMENT DISTRICT," AUTHORIZING AND SPECIFYING THE IMPROVEMENTS TO BE PROVIDED, ESTABLISHING THE METHODS UNDER WHICH THE ASSESSMENTS ARE TO BE LEVIED, DESCRIBING AND ESTABLISHING THE BOUNDARIES OF THE DISTRICT, AND PRESCRIBING OTHER MATTERS AND DETAILS RELATING TO THE ESTABLISHMENT AND OPERATION THEREOF.

BE IT KNOWN AND REMEMBERED:

THAT, the County Council of Salt Lake County, State of Utah (the "Council") met in regular session of the Council on the State of Utah (the "Council") met in found the following:

WITNESSETH:

WHEREAS, the Council is vested with the legal authority to create special improvement districts within the unincorporated area of Salt Lake County with the power to make or cause to be made public improvements pursuant to the powers vested in the Council by Utah Code Ann. 17A-3-204; and

WHEREAS, the Council duly published and mailed its notice of intent to create a special improvement district for the purpose of making roadway improvements, and levying assessments therefor, for sections of 7300 West, 13700 South and 23800 South, located west of 6400 West and south of 13400 South in the unincorporated area of Salt Lake County, pursuant to the provisions of Utah Code Ann. 17A-3-205 and 206; and

WHEREAS, subsequent to the publishing and mailing of the notice of intent and within the protest period provided by law, the Council received six (6) written protests to the creation of the proposed special improvement district or other objections relating to the notice of intent; after the expiration of the time fixed in the notice as the last day for the filing of protests, the Council received a "Petition" from certain property owners petitioning that their property not be included in the proposed district; and

WHEREAS, the Council conducted a public hearing on March 11, 2003, on the date and at the time and place specified in the notice of intention, and duly considered all protests filed and heard statements from interested persons who appeared and spoke in favor of or in opposition to the creation of the proposed special improvement district. The Council thereafter adjourned the hearing and continued the matter for further review and consideration; and

WHEREAS, the Council has duly considered all protests timely received and does hereby determine that there are insufficient protests received to prohibit the creation of the proposed special improvement district, and that all residents and owners of all properties of the area to be included in the district will benefit from the improvements to be provided therein; and

WHEREAS, after due consideration of the arguments both in favor of and in opposition to the creation of the proposed special improvement district, the Council now determines that it would be in the best interests of Salt Lake County and the affected property owners to proceed at the present time to create the proposed special improvement district; and

WHEREAS, the Council has taken all actions and accomplished all matters required and necessary which are preliminary to the creation of a special improvement district and, accordingly, does hereby determine that the district shall be created in accordance with this

Resolution and the County Improvement District Act (the "Act"), section 17A-3-201, et seq., Utah Code Annotated.

RESOLUTION

NOW, THEREFORE, the County Legislative Body of Salt Lake County resolves as follows:

SECTION 1. There is hereby created and established in the County of Salt Lake, State of Utah, a special improvement district, the area of which is described in section 5, below. The District is ordered and declared duly formed, organized and established under and by virtue of the Act, and shall be a dependent county improvement district.

SECTION 2. The Name of the District created hereby is and shall be hereafter known as "7300 West Area Special Improvement District," hereafter referred to in this Resolution as the "District."

SECTION 3. The District shall have and exercise through its proper officers all of the rights, powers and authority conferred upon special improvement districts by and included in the Act and as otherwise provided by law for the purposes has herein provided.

SECTION 4. The purpose of the District is to improve the public roadways located within the District to meet minimum Salt Lake County rural road standards, including pavement and drainage, so that the roadways may be included in the County's year round maintenance plan. The improvements to be made will include upgrading the roadways to County rural standards, including road base and asphalt to a width of twenty (20) feet, plus a reasonable shoulder, together with any necessary drainage facilities.

SECTION 5. Except for the property parcels deleted from the District below, the area

and boundaries of the District shall include all of the lots adjacent to or using the following roadways as their primary access:

7300 West from 13400 South to Rose Canyon Road, 13700 South from 7300 West to the Herriman City Boundary, and 13800 South from 7300 West to the Herriman City Boundary.

The following parcels of property are hereby deleted from the District for the reasons stated:

SECTION 6. Except for the property parcels excepted from assessment below, there is hereby authorized the levy of an assessment on all property in the District to pay all or a portion of the cost of the improvements, according to the estimated direct and indirect benefits to be derived from them by the property. The method under which the assessment will be levied shall be a combination of the following methods: (1) seventy percent (70%) of the assessment according to the number of lots in the District; and (2) thirty percent (30%) of the assessment according to roadway frontage. With regard to corner lots, there will be no lot assessment for improvements on the second street of a corner lot, and there will be a deduction of seventy (70) feet from the total roadway frontage. The following parcels of property are hereby excepted from levy of an assessment for the reasons stated:

SECTION 7. In accordance with the Act, the Salt Lake County Council shall be and act as the governing authority of the District and shall supervise and control all of the activities thereof. For this purpose, the Council may delegate to a manager or to an elective or appointive delegate the authority to perform the activities, functions and operations of the District and exercise the rights, powers, and authority of the District.

SECTION 8. All officers and employees of Salt Lake County are hereby authorized and directed to take all actions necessary and appropriate to effectuate the provisions of this Resolution.

SECTION 9. This Resolution or a summary thereof shall be published in its entirety in a newspaper of general circulation in Salt Lake County but such publication shall not be necessary for this Resolution to be or become effective.

SECTION 10. In accordance with section 17A-3-207(7) of the Act, the County Clerk is directed to file, within 5 days from the date of the creation of the District, in the County Recorder's Office, a copy of the Notice of Intention and the Resolution creating the District, as finally approved, together with a list of properties proposed to be assessed described by tax identification number and a valid legal description of property within the District.
