The City of Draper, a municipal corporation of the State of Utah, Grantor, hereby GRANTS and CONVEYS to the UTAH DEPARTMENT OF TRANSPORTATION, at 4501 South 2700 West, Salt Lake City, Utah 84119, Grantee, for the sum of Ten / 100 - Dollars, a perpetual easement, upon part of an entire tract of property situate in the NE¼SE¼ of Section 26, T.3 S., R.1 W., and the NW¼SW¼ of Section 25, T.3 S., R.1 W., SLB&M., for the purpose of constructing thereon public utilities, and appurtenant parts thereof, to facilitate the widening of 12300 South Street, known as Project No. 0071. The boundaries of said part of an entire tract are described as follows:

Beginning at the intersection of the southerly highway right of way line of said 12300 South Street and the westerly boundary line of said entire tract, at a point 53.00 feet radially distant southerly from the centerline of said 12300 South Street, opposite Engineers Station 214+95.63, which point is 1566.77 feet N. 0°05'11" W. along the Section line and 36.00 feet West from the Southwest corner of said Section 25; and running thence Easterly, 44.06 feet along the arc of a 7947.00-foot radius curve to the right, chord to said curve bears N. 88°08'07" E. for a distance of 44.06 feet; thence S. 89°59'18" E. 27.97 feet to the easterly boundary line of said entire tract; thence S. 0°05'11" E. 9.21 feet along said easterly boundary line; thence westerly 72.03 feet along the arc of a 7937.00-foot radius curve to the left, chord to said curve bears S. 88°14'02" W. for a distance of 72.03 feet to the westerly boundary line of said entire tract; thence N. 0°05'11" W. 10.00 feet to the point of beginning
