AMENDMENT TO BYLAWS OF THE ORCHARD OF COUNTRY WOODS CONDOMINIUM PROJECT

The Bylaws of the Orchard of Country Woods Condominium Project, which Bylaws are dated September 19, 1979 and recorded with the Salt Lake County Recorder as Entry No. 3339570 in book 4948, pages 275 - 287, concerning the parcel of real property set forth on Exhibit A attached hereto and made a part hereof, are hereby amended as follows:

- 1. Article II, Section 4 of the Bylaws is hereby amended to read as follows:
- 4. Annual Meeting. The annual meeting of the Association shall be held during the first quarter of each calendar year, as determined by the Management Committee. The place of the meeting shall be at a location in Salt Lake County, State of Utah as specified in the notice of meeting. At least ten but not more than thirty days before the date of the annual meeting a written notice thereof shall be personally delivered or mailed postage prepaid to each person who appears as an Owner at the latest address of such person appearing in the records of the Committee at the time of delivery or mailing. Such notice shall state the time, place, and general purpose of the meeting.
 - 2 Article III, Section 1 (1) of the Bylaws is hereby amended to read as follows:
- (l). Keeping books with detailed accounts of the receipts and expenditures affecting the property and the administration of the Project, specifying the maintenance and repair expenses of the Common Areas and any other expenses incurred. The said books and vouchers accrediting the entries thereupon shall be available for examination by the Owners, their duly authorized agents or attorneys, at a mutually convenient time. All books and records shall be kept in accordance with generally accepted accounting practices, and the same, upon resolution of the Association, shall be audited at least once a year by an outside auditor

employed by the Committee who shall not be a resident of the project, or an owner therein. The cost of such audit shall be a common expense. A copy of the audit report shall be supplied to any first mortgagee of any unit in the project who requests the same in writing from the secretary.

3 All other provisions of the bylaws shall remain in full force and effect.
