WALTER HEYMAN, MARK CHRISTIANSEN, DONALD CHISHOLM *Special Agent Idaho Power Co. Dist.*
Grantors of Pleasant View City, County of Weber, State of Utah, hereby convey and do grant to WEBER-BOX ELDER CONSERVATION DISTRICT, a body corporate and politic of Weber County, Utah, Grantee, its successors and assigns forever, an easement and right-of-way for the sum of ONE and No/100 DOLLARS (\$1.00) receipt of which is hereby acknowledged and other valuable consideration with the right from time to time hereafter to erect, install, lay, use, maintain, replace, repair, operate, increase or decrease the size of or remove a water pipeline for the purpose of transmitting and distributing water on, over, under, and across the following described parcel of land:

A strip of land 5.0 wide lying North of the State Road's North right-of-way line that lies within the following described lands:

DESCRIPTION OF PROPERTY: Serial Number 17-072-0009
Part of the Northwest Quarter of Section 32, T7N, R1W, SLB&M, U.S. Survey: Beginning on Corporate limits 1231.5 feet East and 5.9 chains South 0D47' West of the Northwest Corner of said Quarter Section, running thence South 9.14 chains, thence South 89D45' East 499.68 feet, thence North 9.14 chains, thence North 89D45' West 499.68 feet to beginning.

DESCRIPTION OF PROPERTY: Serial Number 17-072-0013
Part of the Northwest Quarter of Section 32, T7N, R1W, SLB&M, U. S. Survey: Beginning 1.23 chains East and 4.12 chains South of the Northwest Corner of said Quarter Section; thence South 8.04 chains; thence East 4.24 chains; thence South 2.46 chains; thence South 89D45' East 870.48 feet, more or less, to the Townsite line; thence North 47' East 9.14 chains; thence North 89D45' West 490 feet; thence North to point East of beginning; thence West to beginning.

After installation of the pipeline, the District shall promptly restore the surface of any of the lands disturbed thereby to their former state and condition to the satisfaction of the Owner. This is to include fences and irrigation ditches.

This grant also includes the right of ingress or egress for all purposes incident to such easement and right and it is expressly understood that no buildings or other structures or trees will be placed under or over such lines and in said right-of-way or easement.

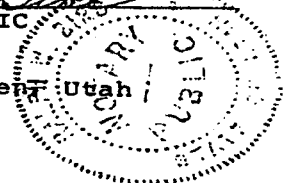
