- 3. Exclusive Common Area. The Declarant reserves the right to designate a portion or portions of the Common Area as Exclusive Common Area until the end of the Period of Declarant's Control or all of the Additional Land has been added to the Project, whichever last occurs. The Declarant may designate Exclusive Common Area or change such designation by recording a Supplemental Declaration with the Office of the County Recorder indicating the Exclusive Common Area and the Unit or Units to which it is assigned. In addition, as long as the Declarant owns any of the Property, its consent shall be required for any designation or change in designation of Exclusive Common Area.

6. Effective Date. The effective date of this Amendment to the Declaration shall be the date on which said instruments are filed for record in the Office of the County Recorder of Salt Lake County, Utah.
