THIS INDENTURE, made this 21st day of March, 1925, between MacLEAN COAL COMPANY, a corporation organized and existing under and by virtue of the laws of the State of Utah, party of the first part, and MUTUAL COAL COMPANY, a corporation organized and existing under and by virtue of the laws of the State of Utah, party of the second part:

WITNESSETH, that the party of the first part for and in consideration of the sum of One Dollar and the other good and valuable considerations to the said party of the first part in hand paid by the party of the second part, receipt whereof is hereby acknowledged, has granted, bargained, sold and conveyed and by these presents does grant, bargain, sell, convey and confirm unto the said party of the second part, its successors and assigns forever, an easement and right of way over and across the real estate hereinafter described for the purpose of constructing, operating and maintaining thereon, a standard gauge railroad track as now constructed or as second party or its successors may desire to construct the same, saidright of way and easement being a strip or parcel of land in the SW1 of the NE1 of Section 7, Township 13 South, Range 9 East of the Salt Lake Base and Meridian along the line of said Mutual Goal Company's main spur track as the same is now constructed upon the ground, being more particularly described as follows, to-wit:
