ABANDONMENT OF RIGHT-OF-WAY AND EASEMENT

The Jordan Valley Water Conservancy District, formerly known as the Salt Lake County Water Conservancy District, hereby abandons, effective as of April 26, 2000, its interest, if any, to the following right-of-way and easement granted to, or acquired by, the Jordan Valley Water Conservancy District and which originated in that Right of Way Agreement No. 19, dated May 22, 1941, recorded January 16, 1942, Entry No. 921431, Page 62, Book 298, including the portion thereof described below, situated within Lot 2, Hidden Park Subdivision, Salt Lake County, Utah:

A right-of-way and easement 10 feet in width, 5 feet to the left, or south side, and 5 feet to the right, or north side, with side lines extending and shortening so as to commence at the East boundary line of Lot 2, Hidden Park Subdivision and terminate at the West boundary line of Lot 2, Hidden Park Subdivision, of the following described centerline:


Beginning at a point on the East boundary line of Lot 2, Hidden Park Subdivision, Salt Lake County, Utah, said point being South 0°13'18" West 1331.20 feet and South 89°56'22" West 79.00 feet and North 0°00'31" West 21.65 feet from the North Quarter Corner of Section 33, Township 2 South, Range 1 East, Salt Lake Base and Meridian, and running thence North 70°07'00" West 132.74 feet to the West boundary line of Lot 2, Hidden Park Subdivision.

This abandonment does not affect any other right-of-way and/or easement, specifically including that right-of-way and easement granted to the Jordan Valley Water Conservancy District which affects a portion of Lot 2, Hidden Park Subdivision, as shown by the official plat of the Hidden Park Subdivision.
