Eva Alice Robinson grantor of Salt Lake, County of Salt Lake State of Utah, hereby grants, bargains and sells to the STATE ROAD COMMISSION OF UTAH, Grantee, for the sum of Forty 50/100 DOLLARS, the following described right of way across the grantors land in Salt Lake County, State of Utah, as follows:

Right of way for highway known as F.A.S. Project No. 102 across the grantors land in the NE 1/4 SE 1/4 of Section 27, T. 4 S., R. 1 W., S.L.M. Said right of way is a parcel of land 100 ft. wide, 50 ft. on each side of the center line of survey of said project. Said center line is described as follows:

Beginning at the intersection of the north line of said SE 1/4 of Section 27 and said center line of survey at Engineer's Station 199445, which point is 1138 ft. west along said north line from the east 1/4 corner of said Section 27; thence S. 19°36'E., 706.5 ft. to the intersection of said center line of survey at Engineer's Station 206451.5 and the south boundary line of said grantors land, which point is 1138 ft. west along said north line of the SE 1/4 and 706.5 ft. Right of way for highway known as F.A.S. Project No. 102 across the grantors land in the NW 1/4 SE 1/4 of Section 22, T. 4 S. R. 1 W., S. L. M. Said right of way is a parcel of land, the boundaries of which are described as follows:
