3. Said errors and their corrections are as follows:

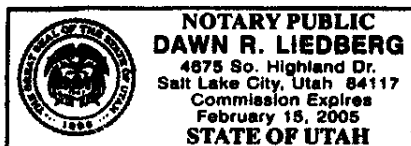
- (a) Lot 101 The South line will change from 132.74 feet to 154.16 feet. 28-27-155-006
