A perpetual easement, upon part of an entire tract of property, situate in the NE $\frac{1}{4}$ NW $\frac{1}{4}$  of Section 15, T. 3 S., R. 1 W., S.L.B.&M., for the purpose of constructing and maintaining thereon a signal pole and appurtenant parts thereof incident to widening and grading of Redwood Road, known as Project No. 0068. The boundaries of said part of an entire tract are described as follows:

Beginning in the westerly right of way line of said Redwood Road, at a point 53.02 ft perpendicularly distant westerly from the center line of said project at Engineer Station 512+58.01, said point of beginning is approximately 53.00 ft S 89°47'38" W along the Section Line and 61.19 ft S 00°05'20" W from the North Quarter Corner of said Section 15; thence S 00°05'20" W 25.00 ft along said right of way line; thence West 5.00 ft; thence N 00°05'20" E 25.00 ft; thence East 5.00 ft to the point of beginning. The above described part of an entire tract contains 125 square feet in area or 0.003 acre, more or less.

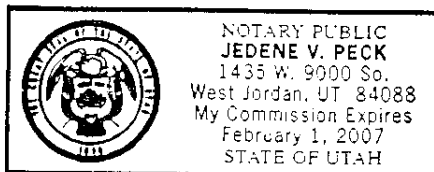
