### EASEMENT

Great Salt Lake Minerals & Chemicals Corporation, a corporation doing business in the State of Utah, Grantor, hereby conveys and warrants to UTAH POWER & LIGHT COMPANY, a corporation, its successors in interest and assigns, Grantee, for the sum of One (\$1.00) Dollar and other valuable consideration, a perpetual easement and right of way for the erection, operation and continued maintenance, repair, alteration, inspection, relocation and replacement of the electric transmission and distribution circuits of the Grantee, and no poles and two guy anchors, with the necessary stubs, crossarms, braces, and other attachments affixed thereto, for the support of said circuits on, over, under and across a tract of land located in Weber County, Utah, described as follows:

One guy anchor located on the Grantor's land at a point 3065 feet north and 445 feet west, more or less, from the south one quarter corner of Section 7, T. 6 N., R. 3 W., S.L.M., and being in the SE 1/4 of the NW 1/4 of said Section 7.

One guy anchor located on the Grantor's land at a point 3000 feet north and 445 feet west, more or less, from the south one quarter corner of Section 7, T. 6 N., R. 3 W., S.L.M., and being in the SE 1/4 of the NW 1/4 of said Section 7.

This easement is granted in accord with and supplements a prior easement dated December 12, 1967 and recorded on the 16th day of February, 1968, in the office of the County Recorder of Weber County, Utah, in Book 882 at Page 593.

Together with all rights of ingress and egress necessary or convenient for the full and complete use, occupation and enjoyment of the easement hereby granted, and all rights and privileges incident thereto, including the right to cut and remove timber, trees, brush, overhanging branches and other obstructions which may injure or interfere with the Grantee's use, occupation or enjoyment of this easement.
