Tracy Land and Livestock Company a corporation of the State of Utah, Grantor, hereby QUIT CLAIMS to the STATE ROAD COMMISSION OF UTAH, Grantee for the sum of One and no/100 Dollars, the following described tract of land in Summit County, State of Utah, to-wit:

A tract of land for highway known as Project No. 0189 situated in Lot 4 of Section 30 and Lots 1, 2, 3, & 4 of Section 31, T. 1 S., R. 5 E., S.L.M. Said tract of land is bounded on the easterly side by a line parallel to and 50.0 ft. distant easterly from the center line of survey of said project and bounded on the westerly side by the existing westerly right of way fence, from the north line of said Lot 4 of Section 30 to a point directly opposite Engineers Station 21+00 and thence by a straight line to the south boundary line of Summit County at a point 50.0 ft. radially distant westerly from said center line. Said center line is described as follows:

Beginning at the intersection of said north line of Lot 4 of Section 30 and said center line of survey at Engineers Station 80+72 which point is approximately 318 ft. west along said north line from the NE. corner of said Lot 4 of Section 30; thence S. 25° 45' W. 681 ft. to a point of tangency with a 5° 00' curve to the left; thence Southerly 973.7 ft. along the arc of said curve; thence S. 22° 56' E. 316.0 ft. to a point of tangency with a 5° 00' curve to the right; thence Southerly 632.7 ft. along the arc of said 5° 00' curve to the right; thence S. 08° 42' W. 908.3 ft. to a point of tangency with a 4° 00' curve to the left; thence Southerly 397.5 ft. along the arc of said 4° 00' curve; thence S. 07° 12' E. 340.3 ft. to a point of tangency with a 4° 00' curve to the right; thence Southerly 322.5 ft. along the arc of said 4° 00' curve to the right; thence S. 05° 42' W. 1438.2 ft. to a point of tangency with a 6° 00' curve to the right; thence Southerly 51 ft. along the arc of said 6° 00' curve to the intersection of said center line of survey

at Engineers Station 20+10 and said south boundary line of Summit County, which point is approximately 720 ft. north and 642 ft. east from the SW. corner of said Section 31 as shown on the official map of said project on file in the office of the State Road Commission of Utah. Above described tract of land contains 13.92 acres, more or less, of which 9.89 acres, more or less, are now occupied by the existing highway. Balance 4.03 acres, more or less.

The grantors also hereby grant to the grantee permission to locate and construct within the grantors land and outside the limits of the highway right of way all irrigation and/or waste water ditches made necessary by the construction of said project. After the above described ditches are constructed, the grantee is thereafter relieved of all responsibility for the maintenance of said ditches.

Any and all water rights pertaining to the above described land are hereby reserved by the grantor, and the grantee shall not be liable for any water assessments now due or which shall become due.

In executing this deed, the grantor hereby further grant to the grantee the right to use that portion of the grantors remaining property as necessary to construct thereon cut and/or fill slopes.

Said tract of land is contained within two side lines parallel to and at distances of 50.0 ft. northwesterly and 50.0 ft. southeasterly from the center line of survey of said project. Said center line is described as follows:
