

ELECTION NOTICE

Silver Creek Estates, Unit I, Summit County, State of Utah

Effecting Declaration of Reservations and Protective Covenants, originally filed Feb. 25, 1965

NOW, THEREFORE, KNOW ALL MEN BY THESE PRESENTS:

An election was held by and on behalf of all lot owners of Unit I, Silver Creek Estates, on October 20, 2010, 7:00 p.m. at 7182 Silvercreek Rd., Unit C. The purpose for the meeting was to elect, declare and certify three members to serve on the Committee of Architecture for said Unit I. Also approved by a vote of the lot owners, pursuant to the General Provisions clause in the "Declaration of Reservations and Protective Covenants" the following propositions were authorized. Each lot owner being permitted 1 vote.

Out of 120 lot votes possible, 97 lot owners were represented (81%) and cast their votes as follows:

PROPOSITION I

#1 - Section C - To amend "C-1 Land Use Regulations" and -- ALL PRESENT PERMITTED USES to remain as written, however, UNIT I lot owners hereby grant the Committee of Architecture authorization to expand permitted uses to be equal to and include any and all other uses permitted by Summit County presently authorized under Neighborhood Commercial, Community Commercial, and Service Commercial/Light Industrial Zoned, and Town Center areas.

There were a total of 96 (99%) votes in favor of Proposition 1.

PROPOSITION II

#2 - Pursuant to "A - Committee of Architecture" See 2 & 3, to amend C-1, R-4, P-1, and M-1 -- SETBACKS & MAXIMUM BUILDING HEIGHTS, lot owners hereby authorize the Committee of Architecture to expand conditions to accommodate the needs of present and future development in regards to but not limited to service stores and shopping center and all other uses permitted by Summit County presently authorized under Neighborhood Commercial, Community Commercial, and Service Commercial/Light Industrial Zoned and Town Center areas.

There were a total of 97 (100%) votes in favor of Proposition 2.

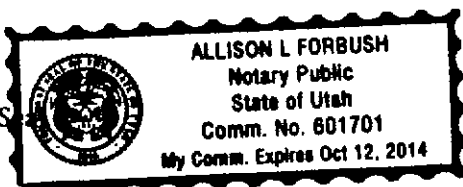
