FIRST AMENDMENT TO DECLARATION OF PROTECTIVE COVENANTS, CONDITIONS & RESTRICTIONS FOR

HERRIMAN HEIGHTS SUBDIVISION

THIS FIRST AMENDMENT (the "First Amendment") is made and entered into this 6th day of July, 2004, by HERRIMAN HEIGHTS, L.C. (the "Declarant").

RECITALS:

- A. Declarant previously executed and recorded the following as part of the entire project:
 - (i) Herriman Heights Subdivision recorded April 5, 2004 as entry No. 9023753, in book number 2004P on page number 78 of the official records of the Salt Lake County, State of Utah (the "Plat").
 - (ii) A Declaration of Protective Covenants, Conditions and Restrictions for Herriman Heights Subdivision, dated April 5, 2004, which was recorded April 5, 2004, as entry No. 9023754 in book number 8968, at pages 5610-5622, of the official records of Salt Lake County, State of Utah (the "Declaration").
- B. Declarant desires to amend the Declaration in certain respects.

NOW, THEREFORE, in consideration of the foregoing covenants and promises contained herein, and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Declarant agrees as follows:

- 1. The following sections of the Declaration shall be amended as follows:
 - (a) The existing Paragraph 2.5 of the Declaration shall replace the sentence that reads: "On corner lots which have side yards that border a street, no building shall be located on that lot nearer to the side lot line than thirty (30) feet" with two entirely new sentences to read as follows: "For lots 28 through 44 and lots 60 through 62, inclusive, on corner lots which have side yards that border a street, no building shall be located on that lot nearer to the side lot line than thirty (30) feet. For lots 1-28, inclusive and lots 45-49, inclusive, on corner lots which have side yards that border a street, no building shall be located on that lot nearer to the side lot line than twenty (20) feet."
- 2. In all other respects, the Declaration and Plat are ratified and affirmed.
- 3. The vote required for amendment of the Declaration of Covenants has occurred, in accordance with the Amendments portion of the Declaration.
