1. <u>DESCRIPTION OF MODIFICATIONS</u>. The HOMEOWNER wishes to make the following modifications to the above-described condominium unit at the HOMEOWNER'S sole expense:

Installation of six(6) 14 inch solar tube skylights.

- 2. <u>GRANT OF LICENSE</u>. BROOKSTONE hereby grants HOMEOWNER permission to install said modifications subject to the terms and conditions of this Agreement.
