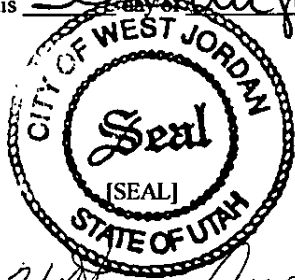
CITY ENGINEER'S AFFIDAVIT OF STREET ADDRESSES ASSIGNMENT
