**WHEREAS**, EAGLE MOUNTAIN CITY, a Utah municipality, 1650 E. Stagecoach Run, Eagle Mountain, Utah 84005 (the “City”) has agreed with the STATE OF UTAH, SCHOOL AND INSTITUTIONAL TRUST LANDS ADMINISTRATION (the “Trust Lands Administration”) to grant certain development approvals as described in that certain Amended and Restated Master Development Agreement DEVL 1112 between the City, Ivory Homes, Ltd. and the Trust Lands Administration dated December 5, 2017 (the “Master Development Agreement”) in consideration of and exchange for the dedication of the lands hereinafter described to the City, pursuant to the laws of said State,

**AND WHEREAS**, the said agreement by the City complies with all applicable statutory requirements for exchange, it having been determined by the Trust Lands Administration that such development approvals equal or exceed the value of the subject land;

**NOW THEREFORE I**, GARY R. HERBERT, Governor, by virtue of the power and authority vested in me by the laws of the State of Utah, do issue this PATENT, in the name and by the authority of the State of Utah, hereby granting and confirming unto the said EAGLE MOUNTAIN CITY, and to its successors and assigns forever, the tract or parcel of land (the “Subject Property”), situated in the County of Utah, State of Utah, to-wit:

**Pony Express Parkway – Additional Right-of-Way**  
Township 5 South, Range 2 West, SLB&M  
Section 36: within; containing 3.75 acres, more or less

Township 6 South, Range 2 West, SLB&M  
Section 1: within; containing 4.58 acres, more or less  
Section 12: within; containing 1.88 acres, more or less

The Pony Express Parkway – Additional Right-of-Way is more specifically described in **Exhibit A** and generally depicted in **Exhibit B** hereto and incorporated by reference

**TO HAVE AND TO HOLD** the above described and granted premises unto the said EAGLE MOUNTAIN CITY, a Utah municipality, and to its successors and assigns forever,

Excepting and reserving to the State of Utah, for the benefit of the State and its successors in interest, assigns, permittees, licensees and lessees from time to time, all coal, oil, gas and other hydrocarbons and other mineral deposits, along with the right for the State of Utah or other authorized persons or entities to prospect for, mine, and remove such deposits; also,

Subject to any valid, existing rights of way of any kind and any right, interest, reservation or exception appearing of record, subject to exceptions and reservations contained in federal patents and clear lists, and subject also to all rights of way for ditches, tunnels, and telephone and transmission lines that have been or may be constructed by authority of the United States as provided by statute; also,

Subject to an express covenant that the lands granted herein shall only be used as a utility corridor, public road and for improvements associated with utilities and public roads (the "Covenant"); also,


Subject to a reversionary interest held by the State of Utah as follows: In the event that the City or its successors in interest, as to all or part of the subject land, ceases to use such land for the purposes set forth in the Covenant, then title to and ownership and possession of the subject lands shall automatically revert to the Trust Lands Administration or its successor agency.


