Pole Line Easement

W. J. Bastian and Margaret Bastian, his wife; and J. Bastian and Azalea Bastian, his wife, Grantors, of Salt Lake County, Utah, hereby convey and warrant to UTAH POWER & LIGHT COMPANY, a corporation, its successors in interest and assigns, Grantee, for the sum of One (\$1.00) Dollar and other valuable consideration, a perpetual easement and right of way for the erection and continued maintenance, repair, alteration, and replacement of the electric transmission, distribution and telephone circuits of the Grantee, and one guy anchor and four poles, with the necessary guys, stubs, crossarms and other attachments thereon, or affixed thereto, for the support of said circuits, to be erected and maintained upon and across the premises of the Grantors, in Salt Lake County, Utah, along a line described as follows:

Beginning at fence on north boundary line of Grantor's land at a point 865 feet west, more or less, from the east quarter corner of Section 32, T. 3 S., R. 2 W., S.L.B. & M., thence running S. 24°18' E. 629 feet to existing pole line on said land and being in the NE 1/4 of the SE 1/4 of said Section 32.

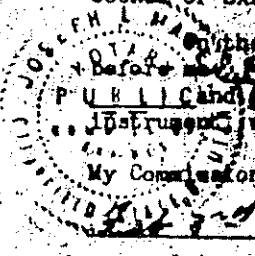
Together with all rights of ingress and egress necessary or convenient for the full and complete use, occupation and enjoyment of the easement hereby granted, and all rights and privileges incident thereto, including the right to cut and remove timber, trees, brush, overhanging branches and other obstructions which may injure or interfere with the Grantee's use, occupation, or enjoyment of this easement.

This easement is executed and delivered as a correction to that certain Pole Line Easement dated June 23, 1941 from W. J. Bastian and Margaret Bastian, his wife, and W. J. Bastian and Azalea Bastian, his wife, to Utah Power & Light Company, which was recorded July 29, 1941 as Instrument No. 910170; records of Salt Lake County, Utah, in Book 280 of Deeds at page 201, wherein the description was erroneous.
