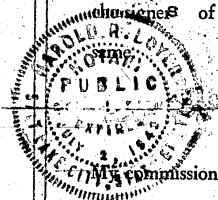

QUITCLAIM DEED

*Paul Lyle Merlson* and *Ercost J. Merlson*, husband and wife, of Holliday, County of Salt Lake, State of Utah, *et al.*, hereby Quitclaim to *JERRY GULIN*, of Murray, County of Salt Lake, State of Utah, *et al.*, for the sum of Ten Dollars, the following described tracts of land in Salt Lake County, State of Utah:

The East one-half of the Northeast Quarter of the Southeast Quarter of Section 21, Township 2 South, Range 3 East, Salt Lake Meridian;

The East one-half of the Southeast Quarter of the Northeast Quarter of Section 21, Township 2 South, Range 3 East, Salt Lake Meridian;

The East one-half of the Northeast Quarter of the Northeast Quarter of Section 21, Township 2 South, Range 3 East, Salt Lake Meridian;

Beginning at a point 99° 35' West 632 feet and North 0° 30' East 410.5 feet from the Southeast corner of the Northeast Quarter of Section 21, Township 2 South, Range 3 East, Salt Lake Meridian, and running thence North 69° 30' West 58 feet; thence North 0° 18' East 231 feet to the center of Big Cottonwood Canyon Creek; thence meandering Southeasterly along the center of said Creek channel 75 feet more or less to a point that is North 0° 30' East 206 feet North of the point of beginning; thence South 0° 30' West 206 feet more or less to the point of beginning; ~~reserving a right of way for road purposes for the use of the public over the South ten (10) feet of said tract of land.~~

And a right of way for road purposes for the use of grantee and the public over the following described tracts of land, to-wit: the East ten (10) feet of the West one-half of the Northeast Quarter of the Southeast Quarter of Section 21, Township 2 South, Range 3 East, Salt Lake Meridian, and the East ten (10) feet of the West one-half of the East one-half of the Northeast Quarter of said Section 21 from a point on the South boundary of said Northeast Quarter of said Section 21 to a point 400.5 feet North of said South boundary and from a point 766.5 feet North of said South boundary of said Northeast Quarter of said Section 21 to the North boundary of said Northeast Quarter of the Northeast Quarter of said Section 21; also over the old county road as it passes over the following described parcel of land, to-wit: Beginning at a point 200.0 feet due West and 260.0 feet due North from the Southeast corner of the Northeast Quarter of said Section 21, and running thence West 100.0 feet due West; thence 435.6 feet due North; thence 100.0 feet due East; thence 435.6 feet due South to the place of beginning.
