Affidavit of the Utah County Zoning Administrator (Partial Release of Agricultural Use Restriction)

This notice serves to release the land described in "Exhibit 1" from a restrictive covenant (*Restrictive Covenant Precluding the Residential or Other Non-Agricultural Use of the Land*) with recordation entry number 22505, recorded March 22, 2000. The restrictive covenant was recorded to qualify for exemption from filing an approved subdivision plat for the division of agricultural land for agricultural purposes.

The land described above comprises only a portion of the land subject to the restrictive covenant. The remaining land is not subject to this release and remains subject to the recorded restrictive covenant.


