PARTIAL RELEASE OF EASEMENTS

PACIFICORP, an Oregon Corporation, dba Utah Power & Light Company (Successor in interest by merger to Utah Power & Light Company, a Utah Corporation), hereby disclaims and releases to the Owners of Record any right, title or interest it may have to a portion of that certain easement recorded as Instrument No. 1135885, September 30, 1948 in Book 637, at Page 356, in the office of the County Recorder of Salt Lake County, State of Utah, as it pertains to the following real property being more particularly described and/or shown on Exhibit "A", attached hereto and by this reference made a part hereof:




